Tom Ford, Director of Administration, addressed the board.

Moved by Falck, seconded by Rost, to send a letter opposing HB 1375 on behalf of the Grand Forks County Commission. Mr. Ford and Ms. Wamstad will draft the letter for the Chair's signature. Motion carried unanimously.

Mr. Ford will be testifying in favor of SB 2306 on Thursday.

Moved by Rost, seconded by Falck, to allow Tom Ford to act on the County's behalf in regards to the use of County property by outside agencies for various events.

Moved by Falck, seconded by Rost, to amend the 2019 capital improvement budget by \$215,000. Motion carried unanimously.

Moved by Knauf, seconded by Rost, to adjourn. Motion carried unanimously. The meeting adjourned at 4:48pm. The next meeting will be held on February 19, 2019.
