AUDIT FINDINGS

Narrative:

An audit of the Grand Forks County Correctional Center (GFCCC) in Grand Forks, North Dakota was conducted on August 29 and 30, 2019 by Candy Snyder, a certified PREA auditor, and assisted by Mark Snyder, an auditing assistant.

An entrance meeting began with the PREA Coordinator, Lt. Hilde. The audit team discussed the plan for the audit. Lt. Hilde provided the staff schedules and an inmate roster. We explained that throughout the next two days we would review personnel files for the application and hiring process to include background checks and applicant's institutional employment history. We would also be reviewing PREA education/training records, screenings, and investigative files. We would be interviewing specialized staff and random staff representing staff covering all shifts and varying degrees of longevity. We would also interview random inmates. Following the entrance meeting Lt. Hilde conducted the audit team on a facility tour. We began with the master control, the booking area and then proceeded through each housing area, all program areas, the laundry and the kitchen.

The auditor then began interviewing specialized staff beginning with the PREA Coordinator, Lt. Hilde. Suitable and private accommodations were made for the auditor to conduct interviews. The auditor was not limited in any way from speaking with staff or inmates or inspecting any area of the facility. The auditor was given access to the facility at all hours of the day in order to conduct interviews with staff on all shifts. The auditor asked specialized questions of staff regarding screenings, searches, first response and the intake process.

The auditor interviewed the Administrator and then outlined the progress on the audit. An exit briefing was held with the PREA Coordinator. The auditor provided a preliminary finding of each standard with the caveat that this was subject to change as the auditor continued to review documents, may have questions to be answered and prepares the audit report. The auditor thanked the GFCCC staff for their hard work and their commitment to follow the Prison Rape Elimination Act and keeping inmates safe.

AUDIT FINDINGS

Facility Characteristics:

The auditor's description of the audited facility should include details about the facility type, demographics and size of the inmate or resident population, numbers and type of staff positions, configuration and layout of the facility, numbers of housing units, description of housing units including any special housing units, a description of programs and services, including food service and recreation. The Grand Forks County Correctional Center (GFCCC) has a capacity of 252 inmates and houses adult male and female inmates. On the first day of the audit the count was 218 inmates. The facility has cameras and intercoms throughout the housing areas. There is non-contact visit only. The GFCCC holds contracts with the U.S. Marshals, the Federal Bureau of Prisons, ICE, and with other North Dakota counties. The GFCC utilizes TurnKey kiosks within the housing units to provide information to the inmates and allow for electronic requests. The auditor scrolled through the kiosks within the housing units to verify that the audit notice, the facility rules and regulations, inmate rights and responsibilities, the information on how to make a report and/or grievance and the contact information for Community Violence Intervention Center (CVIC) was available to inmates. The auditor also noted posters with CVIC's contact information, posters for women's victim support groups held by CVIC within the jail every Tuesday and PREA posters with contact information for ICE detainees. We began the tour in master control where the auditor viewed the cameras and noted that all toilets within the cells are digitally altered with a black box over the toilet area for privacy while toileting. There are three interview rooms and one large visit area for non-contact video visitation. The booking area consists of a booking desk, property storage, two sergeant's offices, two private showers/change out rooms, one group holding cell and ten holding cells. Each of the ten holding cells has two beds and a toilet/sink. There are two padded dry cells. The vehicle sally port is directly off the booking area.

There are three housing pods with six distinct housing units A-F within each pod. Each pod has an elevated duty desk that can directly view into each of the six housing units as well as monitors to view cameras within the housing units. There is one classroom and a recreation area per pod. The individual housing units within a pod consists of a dayroom, and a private shower for the unit. Two of the pods are single tiered for a total capacity of 47 beds and one pod is double-tiered cells with four cells on the dayroom level and four cells on the second tier for a total of 96 beds. Each cell has two beds and a toilet/sink.

There is a 36-bed work release housing area with an open dormitory-style sleeping area with bunks. Work release has a shared shower and toilet room with shower curtains on the stalls for individual privacy. The facility has a training room, staff break room, medical spaces, laundry and a kitchen. Inmate workers work in both the laundry and the kitchen. There are staff offices for the Administrator, Captain, Lieutenants and the PREA Coordinator.

The GFCCC contracts their food service. Meals are prepared on-site and delivered to the housing units and served to the inmates. GFCCC contracts with Grand Forks Public Health Department for health services. Registered Nurses provide health care services within the facility. Inmates are transported to the nearest clinic or hospital for further medical assessment and treatment when necessary. Volunteers provide religious services. There are various types of programming throughout the inmate schedule.

AUDIT FINDINGS

| | The GFCCC has a well-written PREA policy with an effective date of May 1, 2019. PREA policy C.18 superseded previous versions. PREA policy C.18 mandates zero tolerance and outlines the facility's approach to preventing, detecting, and responding to sexual abuse and sexual harassment. The auditor observed that the procedures for following the standards continue to be met through directive and standard operating procedure. The facility has both a PREA Coordinator and a PREA Compliance Manager. The PREA Coordinator continues the excellent work in guiding her facility in compliance with the PREA standards. She has the authority to develop, implement and oversee the efforts and has the complete support of the Administrator. |

This was verified through interviews with both staff and inmates. The facility has good procedures in place that enable inmates to shower, toilet and change clothing without staff of the opposite gender viewing them naked. Inmates shower individually and privately in a single shower. There are digitally applied black boxes on the area of the toilet in the cells. The GFCCC staff were aware of the responsibility of determining sex solely through professional conversation or through medical records or through part of a broader medical examination by a medical practitioner. The facility prohibits cross-gender searches, but provides cross-gender search training in the event an exigent circumstance occurs and provides search training of transgender or intersex inmates. Staff of the opposite gender announce their presence to inmates/detainees when entering in the housing areas.</p> <p data-bbox="247 840 1476 952">CORRECTIVE ACTION: The auditor identified a couple of cells in which the black box needed correction. The facility immediately took action, corrected the error and provided evidence of this to the auditor.</p> |

Typically inmates who do not speak English are brought to the facility by a border patrol agent who has a translator accompanying the agent. The facility does not use inmates to interpret for other inmates. The facility has an active contract with Telelanguage Interpreter Services. They have instructed all staff in the use of these procedures and provided the numbers for this 24-7 service in easily accessible areas for staff. The interpretive services can assist in the intake process, screening process, education on how to report and if need be, translate during the investigative process. Staff work with inmates who may have trouble reading or comprehension due to a disability or cognitive impairment. They read the information and explain it to them at a level they able to understand.</p> |

| | <p>The GFCCC has performed background checks at the time of employment of new hires. The auditor reviewed personnel files to confirm the background check and at the time of employment. They require all background check be ran again every five years. They require three questions at the end of their application and require new hires to affirm that they have a continuing duty to report. The auditor verified this process by a review of personnel files.</p> <p>CORRECTIVE ACTION: The agency did not ask all employees who may have contact with inmates directly about previous misconduct in annual self-evaluations conducted as part of reviews of current employees. The GFCCC immediately took corrective action and asked all current employees about previous misconduct and provided this documentation to the auditor. They will from this point forward include this in the annual review process.</p> |

| | <p>There have been no major expansions or modifications at this facility. They are currently planning an expansion to help with overcrowding and to add more flexibility in how inmates are separated when needed. The administrators consider the ways in which to enhance their efforts and abilities to protect inmates from sexual abuse through the use of communications monitoring and video monitoring. They have camera systems in all key areas. Additionally, they have communications monitoring in which they can hear the conversations within the housing area from the control room and an inmate can call for assistance.</p> |

| | As soon as the administrator is notified of a sexual abuse the protocol is to call the Grand Forks Sheriff Department, and transport the inmate to the Altru Hospital for a SANE Forensic exam. Altru Hospital has 24-hour SANE nursing available. GFCCC has trained investigators to conduct administrative investigations using the 5th Edition (2015) of the North Dakota Sexual Assault Evidence Collection Protocol. GFCCC has a signed Memorandum of Understanding (MOU) with the Grand Forks County Sheriff's Office to conduct criminal investigations. The facility also has a MOU with a local advocate from a rape crisis center, the Grand Forks Community Violence Intervention Center (CVIC). CVIC is the local advocacy agency in Grand Forks. They have trained advocates that provide counseling to survivors. They also provide accompaniments to Altru Hospital. This was verified through both the MOU and a phone call to the CVIC. |

All allegations of potentially criminal behavior are referred to the Grand Forks Sheriff's office. In the twelve months prior to the audit, there were twenty one allegations of sexual abuse and sexual harassment received and one that was referred for criminal investigation. All staff sign a verification document acknowledging understanding of the required training components. Interviews confirm they have received PREA training on as required per the standard. |

| | The facility provides inmates information on GFCCC's zero tolerance policy regarding sexual abuse and sexual harassment and how to report incidents or suspicions of sexual abuse or sexual harassment. This was evident through the interviews with inmates. The facility provides written information and verbally goes over the written orientation information with the inmate and then has the inmate sign the form when complete. They also provide additional comprehensive education during a video with the opportunity to ask questions. This session is completed within thirty days of intake. This more comprehensive training includes their right to be free from sexual abuse and sexual harassment, to be free from retaliation for reporting such incidents, and regarding the GFCCC's policies and procedures for responding to such incidents. This information is continuously and readily available on the TurnKey kiosks located in all housing units. The auditor reviewed training records to verify both the initial training and the more comprehensive training and reviewed the information available on the kiosks. |

The Grand Forks Sherriff's office conducts all potential criminal investigations. The auditor reviewed the screening tool that the GFCCC uses. The facility maintains and uses information about each inmate's personal history and behavior to reduce the risk of sexual abuse by or upon an inmate. The comprehensive screening tool evaluates all points as required by the standard. The questions relating to current charges and offenses history, age, level of emotional and cognitive development, physical size and stature, mental illness and mental disabilities, intellectual or developmental disabilities or physical disabilities are also asked on the medical/mental health screening questionnaire. The inmate is reassessed within 30 days. The auditor interviewed both staff and inmates to verify use of the screening tool.</p> |

| | <p>Screening information is used to make informed housing decisions. There were no transgender or intersex inmates present while the auditor was on-site, but interviews indicate that a transgender or intersex inmate's own views with respect to his or her own safety would be given serious consideration on how they are placed. All inmates shower separately. The facility does not place lesbian, gay, bisexual, transgender, or intersex inmates in particular housing, bed or other assignments solely on the basis of such identification or status, nor does the facility consider lesbian, gay, bisexual, transgender, or intersex identification or status as an indicator of likelihood of being sexually abusive.</p> |

GFCCC would only use protective custody as an alternative means of separation from likely abusers until alternate means of separation can be arranged. Inmates at high risk for sexual victimization or who have alleged sexual abuse who are placed in involuntary segregation would be moved out of involuntary segregation as quickly as possible. In the twelve months prior to the audit, there have been no inmates placed in involuntary segregated housing as a means to keep safe from sexual victimization.</p> |

| | <p>GFCCC provides multiple internal ways for inmates to privately report sexual abuse and harassment, or retaliation. They can report to staff, send a request from the kiosk, write a grievance, put in a sick call slip and report to medical staff. They also can speak with the Administrator, the Lieutenant or the PREA Coordinator by making a request at any time. They can call externally to family, the Sheriff's office or the Community Violence Intervention Center or if a detainee, to the toll free number provided by ICE. These numbers are available the intake orientation form, on posters posted in the facility and on the TurnKey kiosks. The staff accepts reports made verbally, in writing, anonymously, and from third parties and promptly documents any verbal reports. The facility provides inmates with access to tools necessary to make a written report. They also have phone contact with others outside of the facility who can report on their behalf.</p> |

Staff and inmate interviews confirmed their knowledge of how the grievance process can be used to report sexual abuse and sexual harassment, but it does not have to be reported by that method. |
