Kari Goelz, Emergency Manager, addressed the board.

Moved by Pic, seconded by Engen, to approve the following Grand Forks County Emergency Declaration. Motion carried unanimously.

## GRAND FORKS COUNTY EMERGENCY DECLARATION

WHEREAS, Grand Forks County experienced extreme and unprecedented weather conditions including excessive fall rainfall and a fall blizzard resulting in extremely saturated soils, high water tables, and above average flows on the mainstem Red River of the North and its tributaries;

WHEREAS, Grand Forks County has the potential for further damage to roads, bridges, culverts, farmlands, homes, businesses and other public infrastructure facilities from overland flooding and the flooding of the mainstem and tributaries to the Red River of the North as it reaches or exceeds flood stage in the Spring;

WHEREAS, the impact of these potential damages may threaten the health, well-being and public safety of citizens in Grand Forks County; and

WHEREAS, the National River Forecasting Center predicts that there is a greater than 65% chance of major flooding occurring in Grand Forks County resulting in the need for immediate emergency preparedness measures to be enacted;

WHEREAS, the cost of response, cleanup, repair and replacement of such damaged facilities may be in excess of available County resources.

Now, THEREFORE, BE IT RESOLVED that Grand Forks County, a municipal corporation by and through the Board of County Commissioners, Grand Forks County, North Dakota, declares Grand Forks County, its cities, its public and private areas, to be an emergency area and orders the activation and utilization of the Emergency Operations Plan, its procedures, attachments and appendices to monitor the situation, develop a detailed damage assessment, alleviate hardship and initiate appropriate relief actions and mitigation measures by departments and agencies of local government to limit the hardships and impact of the emergency upon the citizens of Grand Forks County.

Moved by Rost, seconded by Falck, to approve the purchase of 400,000 sandbags at cost of .14 per bag from the Emergency fund. Grand Forks City will contribute 50% of the \$56,000 cost. Motion carried unanimously.

Moved by Pic, seconded by Falck, to appoint Leah Gustafson Ista to the Emergency Management Board for an unexpired two year term. The term will expire on March 5, 2020. Motion carried unanimously.

Sheriff Schneider addressed the board.

Tom Ford, Director of Administration, was designated the Grand Forks County Relocation Coordinator for the potential 2020 spring flooding.

Tom Ford, Director of Administration, addressed the board.

Moved by Rost, seconded by Pic, to accept the bid from Tecta America for the construction and replacement of the Grand Forks County courthouse roof for \$118,460. Motion carried unanimously.

Moved by Engen, seconded by Pic, to approve the 2019-2021 Grand Forks Enhanced Use Lease Development Grant #19-21.006 for \$3,000,000, between the North Dakota Department of Commerce and Grand Forks County with Chair's signature. Motion carried unanimously.

State's Attorney Haley Wamstad addressed the board.

Moved by Pic, seconded by Falck, to approve the Chair signature on the Red River Biorefinery Series 2020 bond documents, contingent upon approval by the State's Attorney. Motion carried.

Moved by Pic, seconded by Falck, to create an Asset Forfeiture Board to review applications for expenditures from the Asset Forfeiture fund. The Asset Forfeiture Board will be allowed to approve expenditures up to \$10,000. The board will be comprised of the State's Attorney, Sheriff
