PROCLAMATION BURN BAN GRAND FORKS COUNTY, NORTH DAKOTA May 1, 2018

WHEREAS, Grand Forks County, North Dakota is under abnormally dry conditions; and

WHEREAS, the impact of fires could threaten the health, well-being, and safety of citizens in Grand Forks County; and

WHEREAS, the cost of response and the inordinate equipment wear may be far in excess of available county resources.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Grand Forks County Commissioners declare a Burn Ban for Grand Forks County, North Dakota until further notice.

ANY INDIVIDUAL WHO WILLFULLY VIOLATES THIS BURN BAN IS GUILTY OF A CLASS B MISDEMEANOR, WHICH CARRIES A PENALTY OF UP TO THIRTY (30) DAYS IN JAIL AND A \$1,500.00 FINE PER INCIDENT, AS WELL AS THE COST FOR FIRE SUPPRESSION.
