Bridgie Hansen, Risk Manager, informed the board she will be moving forward with the purchase of the LYNX Security System. The duress alarm system was approved 2/20/2018 for \$40,000.

Elias Dean, Steers Restaurant, addressed the board regarding using the kitchen on the 6<sup>th</sup> floor of the County Office Building for a restaurant. Chairman Falck requested that Mr. Dean meet with Tom Ford, Government Relations Administrator and Lou Lombardi, Veterans Service Officer to develop a proposal to be presented to the Commission at a later date.

Tom Ford, Government Relations Administrator, addressed the board.

Chairman Falck asked Commissioner Engen if he would be willing to serve on the Grand Forks Airport Authority board to replace Commissioner Malm in December 2018. This will be considered at the next meeting.
