The 2019 budget hearing was held.

Debbie Nelson, Finance and Tax Director, presented the 2019 budget.

Mr. Ollman addressed the board regarding the homestead credit. He was directed to the Tax Equalization Office.

Dennis Hanson addressed the board regarding his value.

Moved by Malm, seconded by Knauf, to approve the 2019 budget at \$24,854,556. The budget includes a 1.25% cost-of-living increase for all employees on January 1, 2019, a step increase for all qualified employees on their seniority date and an extra step for employees, on their seniority date, that were affected by the change to policy 103.01. Motion carried unanimously. A copy of the final budget is on file in the County Finance and Tax Office.

Moved by Knauf, seconded by Engen, to approve the service agreements with CVIC, Lutheran Social Services, Attendant Care Services, Circle of Friends Humane Society, Red River Children's Advocacy Center and Greater Grand Forks Community Service and Restitution Program. Motion carried unanimously.

Lane Magnuson, County Planner, addressed the board.

Moved by Malm, seconded by Engen, to approve the application of Shannon Uglem for a variance from the subdivision resolution to allow a lot split in the W ½ of the NW ¼ of Section 10, Arvilla Township with the following condition: That a deed restriction be filed with two proposed parcels that they are to remain in common ownership with the property to the north in the neighboring section. Motion carried unanimously.

Nick West, County Engineer, addressed the board via the telephone.

Mr. West was granted permission to seek quotes for two new plow trucks.

Tom Ford, Government Relations Administrator, addressed the board.

Tom Swoyer, Grand Sky Development Company, addressed the board via telephone.

Moved by Engen, seconded by Knauf, to approve bids for two Grand Sky projects, the Taxi and Apron Repair project to Opp Construction for \$1,599,218, and the Phase II Roadway and Drainage Project to R.J. Zavoral for \$1,513,570. The projects will be reduced to not exceed the \$3,000,000 Grand Forks Enhanced Use Lease Development Grant. Grand Sky Development Company accepts all risk for expenditures over \$3,000,000. Motion carried unanimously.

Moved by Knauf, seconded by Engen, to accept the Greg's Lawn Care Snow Removal Contract. Motion carried with Falck, Engen, Knauf voting aye and Malm voting nay.

Sergeant Andy Schneider addressed the board regarding the use of the Gatehouse at Grand Sky.

Moved by Engen, seconded by Knauf, approve the Grand Sky Security and Gatehouse Memorandum of Understanding. Motion carried unanimously.

Moved by Engen, seconded by Knauf, to limit the use of the County Office Building 6<sup>th</sup> floor kitchen for County and Veterans Service activities only. Motion carried with Falck, Engen, Knauf voting aye and Malm voting nay.

David Jones, States Attorney, addressed the board.

The board directed Mr. Jones to schedule a second law firm, Robbins Geller to give an opioid litigation presentation. Mr. Jones will contact Grand Forks City to see if they would like to participate in the presentation.

The board directed Mr. Jones to work in collaboration with Howard Swanson, Grand Forks City Attorney, on how to proceed with the potential opioid litigation.

Motion by Malm, seconded by Engen, to adjourn. Motion carried unanimously. The meeting adjourned at 6:09pm. The next meeting will be held on October 2, 2018 at 4:00pm.
