Nick West, County Engineer, addressed the board.

Brad Darr, ND Department of Transportation, addressed the board.

Dan Rice, TranSystems, addressed the board.

The board directed Mr. West to contact other counties to develop a unified fee schedule for permitting increased load limits. The fee schedule will be discussed at the January 15, 2019 Commission Meeting.

Moved by Rost, seconded by Pic, to direct Mr. West to contact the North Dakota Department of Transportation regarding the Commission's safety and liability concerns for a statewide bike network plan. Motion carried unanimously.

Bridgie Hansen, Risk Manager, addressed the board.

Moved by Rost, seconded by Pic, to hold over \$40,000 in 2018 capital improvement funds to 2019 for the duress alarm system, if the project is not completed in 2018. Motion carried unanimously.

Lane Magnuson, County Planner, addressed the board.

Moved by Knauf, seconded by Pic, to approve the Special Use Permit and Rezoning requests for Gohl Properties with the following condition: the applicant shall combine the three parcels when the deeds are recorded with the County Recorder's Office. Motion carried unanimously.

Scot Hoeper, Social Services Director, addressed the board.

Moved by Pic, seconded by Knauf, to grant spending authority to Mr. Hoeper to purchase office furniture for the area on the first floor of the County Office Building. The furniture will be for four offices and a conference room, not to exceed \$39,000. Motion carried unanimously.

Commissioner Falck left the meeting. It was 5:15pm.

Moved by Knauf, seconded by Rost, to authorize Vice Chair Knauf to approve any bills that come in before the end of year. Motion carried unanimously.

Moved by Rost, seconded by Pic, to approve the following 2018 budget amendments: 2310 Historical Society - \$4,000, 2350 Senior Citizens - \$15,600,2410 County Fair - \$10, 2542 Keys Grant - \$8,600, 2573 Court Facilities Improvement Grant - \$60,100, 2920 Veterans Services - \$4,000, 2950 Economic Development - \$15,500, 8001 ND State Treasurer - \$100, 8005 Garrison Diversion \$4,800, 8006 Water Resource Board - \$33,200, 8007 County Library - \$29,500, 8008 RR Joint Management - \$16,800, 8010 Ambulance \$83,000, 8019 Regional Airport Authority - \$12,100 and 8063 GFC Soil Conservation District - \$6,400.
