Moved by Falck, seconded by Rost, to recommend appointing Dr. Steve Swiontek to the County Superintendent of Schools position. Motion carried with Engen, Falck and Rost voting aye and Knauf and Pic voting nay.

The recommended appointment of Dr. Steve Swiontek will be forwarded to Grand Forks County School Board Presidents for approval, according to NDCC 15.1-11-01(d).

Lane Magnuson, County Planner, addressed the board.

Moved by Rost, seconded by Falck, to approve a Special Use Permit for J&G Landscaping to add two 40' x 80' cold storage buildings to house equipment for the existing landscaping business, located in section 11, Blooming Township. Motion carried unanimously.

Scot Hoeper, Social Services Director, presented the Human Service Zone Agreement template. The agreement must be submitted to the ND Department of Human Services by December 1, 2019.

Moved by Falck, seconded by Rost, to appoint seven members to the Human Service Zone Board, Commissioner Pic, Scot Hoeper and five members will be selected after the application process. Motion carried unanimously.

The advertisement for the Human Service Zone Board member will run for 30 days.

Nick West, County Engineer, addressed the board.

Moved by Rost, seconded by Knauf, to develop a dust control policy for Commission approval at a future meeting. Motion carried unanimously.

Tom Ford, Director of Administration, addressed the board.

Moved by Pic, seconded by Rost, to accept the quote from Norby's Work Perks for \$13,200 to move the cubicles on first floor south of the County Office Building, prior to the carpet replacement and reassemble cubicles after the carpet is installed. And to accept the bid from Whalen's Moving & Storage of \$3,000 to move the office furniture and store the cubicles and office furniture in two trailers. Motion carried unanimously.

Tom Ford and Kari Goelz, Emergency Manager, informed the board about preliminary discussions they have had with Todd Feland, GF City Administrator, regarding the possible relocation of the Emergency Operations Center (EOC) to the Public Works building. Mr. Ford said he has also been informed that the Grand Forks City Police Department believes they will need the space currently occupied by the Sheriff's Department in 4 to 6 years. Since the EOC should be co-

located with the Sheriff's Department, it would not be cost effective to move the EOC until it is known where the Sheriff's Department will be located.

Tom Ford and the Grand Forks County Commission thanked Gracie Lian for the phenomenal job she did for Grand Forks County as an intern in the Director of Administration's office.

Motion by Rost, seconded by Knauf, to adjourn. Motion carried unanimously. The meeting adjourned at 4:56pm. The next meeting will be held on September 3, 2019 at 4:00pm.
