Debbie Nelson, Finance and Tax Director, presented the 2020 budget.

Moved by Rost, seconded by Pic, to approve the 2020 budget as presented. The budget includes a 2% cost-of-living increase for all employees on January 1, 2020, a step increase for all qualified employees on their seniority date and a 5% increase for the Sheriff and State's Attorney. Motion carried unanimously. A copy of the final budget is on file in the County Finance and Tax Office.

Moved by Falck, seconded by Knauf, to approve the service agreements with CVIC, Lutheran Social Services, Attendant Care Services, Circle of Friends Humane Society, Red River Children's Advocacy Center and Greater Grand Forks Community Service and Restitution Program. Motion carried unanimously.

Bret Burkholder, Correctional Center Administrator, addressed the board.

Moved by Falck, seconded by Knauf, to hire a full time medical clerk, grade 6 step 1, at Correction Center. This position will be hired in place of the 16 hours per week contracted nursing position. Motion carried unanimously.

Sheriff Schneider addressed the board.

Moved by Pic, seconded by Rost, to open the bids for the Sheriff's Department vehicles. Motion carried unanimously.
