Grand Forks County assumes no financial responsibility. Motion carried unanimously. (*The initial authorization occurred on February 20, 2018.*)

Moved by Falck, seconded by Knauf, to approve the removal of The Bank of New York Mellon Trust Company, N.A. as the trustee on the \$60,000,000 Solid Waste Disposal Facility Revenue Bonds Series 2018 and to appoint UMB Bank, N.A. as the successor trustee. Motion carried unanimously.

Debbie Nelson, Finance and Tax Director, addressed the board.

The 2019 Property Appraisal Hearing was opened; no member or representative of any governing body of any taxing district was present, so the hearing was closed.

Moved by Rost, seconded by Knauf, to approve the minimum sale prices on the county tax deed properties and set the property sale for November 19, 2019 at 2:00 pm in the County Commission Room, County Office Building. Terms of sale are cash or check only. Motion carried unanimously.

Kari Goelz, Emergency Manager, addressed the board.

Moved by Pic, seconded by Falck, to accept the proposal for VEOCI software and approve the Chair's signature on the contract. Motion carried unanimously. The 2019 cost will be paid 100% by Grand Forks City and the 2020 cost will be split 50/50 between Grand Forks County and Grand Forks City.

Amber Gudajtes, Tax Equalization Director, addressed the board,

Moved by Rost, seconded by Pic, to approve the reclassification of Whitney Walsh's position from a grade 6, step 2 to a grade 7, step 2, effective November 1, 2019. Motion carried unanimously.

Scot Hoeper, Social Service Director, addressed the board.

Moved by Falck, seconded by Rost, to appoint the following to the Human Service Zone Board: Wayne Trottier and JoNell Bakke to three year terms; Janell Regimbal and Kent Keys to two year terms; and James Remer to a one year term. All terms will begin on January 1, 2020. Motion carried unanimously.

Moved by Pic, seconded by Knauf, to approve the third Tuesday of the month for the meeting date for the Human Service Zone Board beginning January 2020. Motion carried unanimously.

Moved by Pic, seconded by Falck, to approve the Human Service Zone Agreement. Motion carried unanimously.

Moved by Pic, seconded by Knauf, to approve the letter to the ND Department of Human Services regarding the Human Service Zone. Motion carried unanimously.

Sheriff Schneider and Nick West, County Engineer, addressed the board.

Moved by Rost, seconded by Pic, to approve the quote from Valley Petroleum Equipment for \$15,250 to upgrade the fuel system at the Highway Shop. This will be paid from the Sheriff's Department's 2019 budget. Motion carried unanimously.

Commissioner Falck addressed the board.

Moved by Rost, seconded by Pic, to allow ICON Architectural Group to interview the Sheriff's Department, State's Attorney, Juvenile Detention and Emergency Management to study the space needs for a possible new building. ICON Architectural Group will not charge for this study. Motion carried unanimously.

Moved by Rost, seconded by Falck, to disband the East Central County Commissions organization and disburse the remaining funds to the participating counties. Motion carried unanimously.

Motion by Rost, seconded by Knauf, to adjourn. Motion carried unanimously. The meeting adjourned at 4:46pm. The next meeting will be held on November 19, 2019 at 4:00pm.
