It is a three year contract beginning in 2020 for \$26,000 per year. The cost will be split 50/50 between Grand Forks County and Grand Forks City. Motion carried unanimously. This motion supersedes the motion approving a contract on November 5, 2019.

Moved by Pic, seconded by Falck, to approve the renewal of the Cincinnati Insurance Company Directors and Officers Liability Insurance for the Grand Forks County Building Authority with annual cost of \$4,339, effective 12/6/2019 through 12/6/2022. Motion carried unanimously.
