## GRAND FORKS COUNTY COMMISSION MEETING January 8, 2002 – 4:00 P.M.

The Board met pursuant to adjournment with Commissioners Murphy, Kvasager, Malm, and Triplett present. Commissioner Wood absent.

Chairman Murphy called for nominations for Chairman Pro-tem.

Moved by Kvasager, seconded by Malm, to nominate States Attorney James Odegard. Motion carried.

States Attorney James Odegard as parliamentarian adopted Roberts Rules of Order as the official procedure by which the County Commissioners will conduct meetings.

Moved by Triplett, seconded by Malm, to nominate Kvasager to serve as Chairman for the year 2002. Motion carried.

Chairman Kvasager presented a plaque in recognition of being Chairman for the year 2001.

Moved by Murphy, seconded by Triplett, to nominate Malm to serve as Vice Chairman for the year 2002. Motion carried.

Moved by Malm, seconded by Triplett, to approve the minutes of the December 18<sup>th</sup> meeting. Motion carried.

Moved by Malm, seconded by Murphy, to approve the bills as submitted by the County Auditor, Check #7496 thru Check #7716 in the amount of \$304,273.26 and payroll \$630,978.29 for a total of \$935,251.45. Motion carried.

Moved by Triplett, seconded by Murphy, to approve the overtime for the following departments: Sheriff's Department \$637.63, \$475.35 to be reimbursed, Correctional Center \$452.34 and County Highway \$1,850.39. Motion carried.

Richard Onstad, Highway Superintendent, appeared before the Board.

Below is the specifics of the motion that was brought up at the last meeting of the County Commissioners regarding the Farm to Market Road Program.

Moved by Malm, seconded by Triplett, that the program of Farm-to-Market and Federal Aid Roads approved by the electors of Grand Forks County effective January of 1960 for 3 mills, and January of 1985 for five mills, plus statutory additions be changed as follows:

1. That seal costs be added to the program, as required, which was previously discontinued:

- 2. That projects be worked on and completed, as the Board of County Commissioners from time to time shall determine;
- 3. That the rest of the federal aid highway system shall be worked on and completed, including construction, maintaining and resurfacing roads and bridges in accordance with the Grand Forks Transportation Plan and any subsequent plan revisions, and in conformance with N.D.C.C. 57-15-06.3 and any revisions as may be enacted by the legislature; and,
- 4. To extend the existing tax levy shall maintain the program.

That this motion shall be effective until those program projects set forth in the 1960, 1985 elections and as stated in this Motion are completed, according to all mandated requirements, and to the satisfaction of the Board of Commissioners. Motion carried.

Carole McMahon, Planning and Zoning, appeared before the Board.

Moved by Triplett, seconded by Malm, to reappoint John Rodgers and John Fortin to the County Planning and Zoning Commission for another 3-year term, to expire January of 2005. Motion carried.

Moved by Triplett, seconded by Malm, to grant out of state travel to Carole McMahon, to attend a FEMA Conference in Emmetsburg, MD for a week starting 4-15-19, with the cost to the County being meals and her time. Motion carried.

Applications from Roland Young and Darrell Nottestad showing their interest to be appointed to the Water Board.

The Chairman delayed any action on the appointment until a full board is present.

Debbie Nelson, Director of Tax Equalization, appeared before the Board.

The applications for Application for Abatement and Settlement of Taxes received from Lee and Joyce Gensrich, RR#2, Box 82, Hatton, ND, for the years 1999, 2000 and 2001 on property described as W1/2NE1/4, E1/2 NE1/4, and the SE1/4, 19-149-52, Union Township be denied as recommended by the local governing body. Motion carried.

Ms. Nelson informed the Board that agricultural value in Grand Forks will be going up 3.5% per cent due to Title 57 of the NDCC.

Moved by Triplett, seconded by Malm, to set the Board of Equalization Meeting for June 4<sup>th</sup> at 4:30 P.M. Motion carried.

Moved by Malm, seconded by Triplett, to authorize the Commissioners to sign the Residential Property Assessment Policy for Grand Forks County, as presented by the Tax Director. Motion carried.

Gary Gardner, Correctional Center, appeared before the Board.

Moved by Murphy, seconded by Malm, to authorize Mr. Gardner to get the ductwork done in the Correctional Center at a cost of \$28,655.00, \$12,000.00 for the cleaning to come out of the Correctional Center Budget and rest to come out of Capitol Improvements. Motion carried.

Moved by Triplett, seconded by Malm, to authorize Mr. Gardner, to send a letter to Grand Forks City requesting a rate increase for prisoners for 2003. Motion carried.

Moved by Triplett, seconded by Malm, to authorize Mr. Gardner, to fill the position that was budgeted for in 2002. Motion carried.
