Moved by Murphy, seconded by Yahna, to approve the consent agenda. Items in the consent agenda included bills as submitted by the County Auditor, Check #27661 thru Check #27836 in the amount of \$529,180.55, approval of overtime, Veteran Service Office Report, approval of County Deeds and cancel taxes on 49-0001-00097-003, approval of bond for check reissue, and approval of game of chance permits for St Olaf WELCA and Twining PTO.
