The Board met pursuant to adjournment with Commissioners Triplett, Murphy, Kvasager, Yahna and Malm present.

Moved by Malm, seconded by Murphy, to approve the minutes of the October 7, 2004 meeting. Motion carried.

Moved by Malm, seconded by Murphy, to approve the order of agenda. Motion carried.

Moved by Murphy, seconded by Yahna, to approve the consent agenda. Items in the consent agenda included employee status changes, bills as submitted by the County Auditor, Check #31653 thru Check #31866 in the amount of \$330,280.86, approval of overtime, approval of monthly financial report, approval of County Deed on parcel number 44-2901-00113-000 and approval of a game of chance permit for Eielson PTO. Motion carried.

Jim Campbell, Emergency Management Director, addressed the board.

Moved by Kvasager, seconded by Malm, to approve Grand Forks County Emergency Management Office and Altru Health Systems to jointly and cooperatively purchase equipment which will be funded from the 2004 Homeland Security Grant Program. The equipment will be purchased, by and therefore, the property and liability of Altru Health Systems. Upon payment, Altru Health Systems shall be reimbursed \$71,000 by the North Dakota State Division of Emergency Management through the Grand Forks County Emergency Management Office. Motion carried.

Moved by Malm, seconded by Kvasager, to approve Grand Forks County as the applicant and fiscal officer of the Project Safe Neighborhoods Grant in the amount of \$50,116. Grand Forks County will receive \$4,556 for administrative costs. Motion carried.
