## GRAND FORKS COUNTY COMMISSION MEETING December 20, 2005 – 4:00 P.M.

The Board met pursuant to adjournment with Commissioners Murphy, Kvasager, Yahna, Malm and Triplett present. Commissioner Triplett participated via telephone.

Moved by Malm, seconded by Yahna, to approve the minutes of the December 6, 2005 meeting. Motion carried.

Moved by Kvasager, seconded by Malm, to approve the order of agenda adding Sheriff Hill. Motion carried.

Moved by Yahna, seconded by Kvasager, to approve the items in the consent agenda. Items in the consent agenda included employee status changes, bills as submitted by the County Auditor, Check #41529 thru Check #41570 and Check #41673 thru Check #41921 in the amount of \$629,917.88, approval of overtime, Veterans Service Office Report, approval of Liquor and Beer Licenses for Grand Forks Country Club, Hitching Post Bar & Grill and Riverview Golf Course, Inc., GF County Sheriff's Department Transport Stats and K9 Use Summary Report. Motion carried.

## Grand Forks County Resolution for NIMS

WHEREAS, the Grand Forks County Board of Commissioners have declared that the National Incident Management System (NIMS) be put into effect and incorporated by all appropriate entities in the county; and

**WHEREAS**, the Incident Command System components of NIMS are already an integral part of various incident management activities throughout the county, including current emergency management training, exercising and planning programs; and

**WHEREAS**, the local and county Emergency Operations Plan (EOP) incorporates the management principles of NIMS; and

**WHEREAS**, to facilitate the most effective and efficient incident management it is critical that Grand Forks County use standardized terminology, organizational structures, consolidated action plans, unified command structures and comprehensive resource management; and

**WHEREAS**, the NIMS standardized procedures for managing personnel, communications, facilities and resources will improve the county's ability to use federal funding to enhance local and county agency readiness, maintain first responder safety and streamline the incident management process; and

**WHEREAS**, Homeland Security Presidential Directive (HSPD-5) directs county governments to develop and administer NIMS, which would provide a consistent nationwide approach for federal, county and local governments to work together more effectively and efficiently to prevent, prepare for, respond to and recover from domestic incidents, regardless of cause, size of or complexity; and

**NOW, THEREFORE**, **BE IT RESOLVED** that the Grand Forks County Board of Commissioners, do hereby establish the National Incident Management System (NIMS) as the standard for incident management in Grand Forks County.

Executed in Grand Forks, North Dakota, this 20th day of December, 2005. Motion carried.

Moved by Malm, seconded by Yahna, to open the Grand Forks County Sheriff's Department vehicle bids. Motion carried.
