and allow up to \$2,000 for a shelf that will run under the plug mold, to be paid from Capital Improvements. Motion carried.

Moved by Malm, seconded by Yahna, to change Precinct #1 polling site from the Living Word Family Church to the Bible Baptist Church. Motion carried.

Moved by Malm, seconded by Triplett, to purchase a Model 650 Central Ballot Tabulator. The cost is \$45,500 with 50% being paid by the State with Help America Vote Act funds and the remaining 50% from the Election Budget. Motion carried.
