The Board met pursuant to adjournment with Commissioners Kvasager, Murphy, Knauf, Triplett and Malm present.

Moved by Triplett, seconded by Malm, to approve the minutes from the December 7, 2006 meeting. Motion carried.

Moved by Murphy, seconded by Triplett, to approve the order of agenda with Dean Dahl, Information Systems Director, added after the Consent Agenda. Motion carried.

Moved by Triplett, seconded by Knauf, to approve the consent agenda. Items in the consent agenda included employee status change for Amy Opperud, bills as submitted by the County Auditor, Check #120414 thru Check #120442, Check #120545 thru Check #120811 in the amount of \$662,301.70, approval of overtime, approval of Liquor and Beer Licenses for Grand Forks Country Club, Hitching Post Bar & Grill and Riverview Golf Course, Inc. and approval of County Deed on parcel number 44-3113-00321-002. Motion carried.

Moved by Malm, seconded by Knauf, to approve the purchase of a scanner, to be used by the Sheriff's Department, at an estimated cost of \$3300 to be paid from the Computer Budget. Motion carried.

Moved by Murphy, seconded by Triplett, to amend the 2007 Sheriff's Department budget Vehicle line item by \$35,000. Motion carried.

Captain Wagner, Correctional Center Interim Administrator, addressed the board.

Moved by Triplett, seconded by Murphy, to amend the 2006 Correctional Center budget Counseling Fee line item by \$4500 and the 2007 budget by \$18,000. Motion carried with Kvasager, Murphy, Knauf and Triplett voting aye and Malm voting nay.

Moved by Murphy, seconded by Triplett, to approve the Chairman's signature on a Court Facilities Improvement Grant application for improvements to the Courthouse. Motion carried.

Moved by Malm, seconded by Knauf, to authorize Finance Chairman Murphy to approve any bills that come in before the end of the 2006 year. Motion carried.
