GRAND FORKS COUNTY COMMISSION MEETING December 4, 2007 – 4:00 P.M.

The Board met pursuant to adjournment with Commissioners Malm, Triplett, Murphy, Knauf, and Kvasager present. Commissioner Murphy participated via telephone from home due to weather conditions.

Moved by Triplett, seconded by Knauf, to approve the minutes of the November 20, 2007 meeting. Motion carried.

Moved by Murphy, seconded by Kvasager, to approve the order of agenda, replacing item number 7, Blue Cross Blue Shield with the Grand Forks County Regional Correctional Center. Motion carried.

Moved by Kvasager, seconded by Triplett, to approve the consent agenda. Items in the consent agenda included employee status changes for Lee Edward Mewes and Stephanie A. Weis, bills as submitted by the County Auditor, Check #128188 -128245 and Check #128442-128641 in the amount of \$1,543,025.87, approval of overtime and approval of County Deeds on parcel numbers 48-0001-00060-000, 48-0001-00061-000, 48-0001-00062-000, 48-0001-00025-001, 48-0001-00024-000, 42-0001-00028-000, 27-4002-00038-000, 27-4002-00037-000, 44-1803-00160-000, 09-3501-00001-000 and 46-0001-00476-000.
