## GRAND FORKS COUNTY COMMISSION MEETING January 22, 2008 – 4:00 P.M.

The Board met pursuant to adjournment with Commissioners Triplett, Murphy, Knauf, Kvasager and Malm present.

Moved by Kvasager, seconded by Malm, to approve the minutes of the January 8, 2008 meeting. Motion carried.

Moved by Malm, seconded by Knauf, to approve the order of agenda. Motion carried.

Moved by Murphy, seconded by Knauf, to approve the consent agenda. Items in the consent agenda included employee status change for Haley Wamstad, bills as submitted by the County Auditor, Check #129369 thru Check #129654 in the amount of \$1,212,623.44, approval of overtime, approval of County Deeds on parcel numbers 44-1205-00253-000, 44-1205-00166-000 and 44-1101-00001-000, Grand Forks County Veterans Service Office Report and approval of bond for check reissue. Motion carried.

Margaret Tweten, NDSU Extension District Director, addressed the board.

Moved by Kvasager, seconded by Knauf, to allow NDSU Extension Office to start a Youth Commission in Grand Forks County, to teach youth about local government, develop leadership skills and encourage youth to serve their schools and be engaged in their communities. Motion carried.
