The Board met pursuant to adjournment with Commissioners Triplett, Murphy, Knauf, Kvasager and Malm present.

Moved by Malm, seconded by Knauf, to approve the minutes of the October 7, 2008 meeting. Motion carried.

Moved by Malm, seconded by Murphy, to approve the order of agenda adding Bret Burkholder, Correctional Center Administrator after item number 4. Motion carried.

Moved by Murphy, seconded by Malm, to approve the consent agenda. Items in the consent agenda included: employee status change for Andrea Huso; bills submitted by the County Auditor, Check#134932-135238 in the amount of \$477,864.10; overtime; Veterans Service Office Report and the Northwood City Agreement for Performance of Assessing Duties. Motion carried.

Bret Burkholder, Correctional Center Adminstrator, addressed the board.

Moved by Kvasager, seconded by Malm, to approve out-of-state travel for Bret Burkholder to attend a Federal Bureau of Prisons Meeting in Minneapolis, MN on November 18-19, 2008. Motion carried.

Major Mike Fonder, Sheriff's Department, addressed the board.

Moved by Kvasager, seconded by Knauf, to approve the Chair's signature on the North Dakota Department of Transportation Traffic Safety Contract for FY2009. Motion carried with Murphy, Knauf, Kvasager and Malm voting aye and Triplett voting nay.

Chair Triplett said she did have a conversation with Dan Stepan, Red River Water Management Consortium Director at the EERC. Mr. Stepan said they would do a preliminary assessment of the problem with the funds that Grand Forks County has already allocated to the Red River Water Management Consortium. Chair Triplett said that is the way we will proceed if there are no objections.
