## GRAND FORKS COUNTY COMMISSION MEETING December 16, 2008 – 4:00 P.M

The Board met pursuant to adjournment with Commissioners Murphy, Knauf, Malm, Schmisek and Pic present.

Mr. Arvin Kvasager and Ms. Constance Triplett were presented with plaques in recognition of their years of service on the Grand Forks County Commission.

Moved by Malm, seconded by Knauf, to approve the minutes of the December 2, 2008 meeting. Motion carried.

Moved by Schmisek, seconded by Malm, to approve the order of agenda. Motion carried.

Moved by Pic, seconded by Knauf, to approve the consent agenda. Items in the consent agenda included: employee status changes for Amanda Haas, Shellie Smette and Ryan Hanon; bills as submitted by the County Auditor, Check#136296-136340, #136435-136682 in the amount of \$459,198.05; overtime; Liquor/Beer Licenses for Grand Forks Country Club, Rivers Edge Golf Course and the Hitching Post Bar and Grill; and the Grand Forks County Sheriff's Department Transportation Statistics. Motion carried.

Nick Brown, Brown Corporation, addressed the board regarding the New or Expanding Business Exemption for Dakota IV W, LLC. The public hearing was noticed and was held at the December 2, 2008 meeting. A letter was emailed to Peter Welte, States Attorney, by David J. Eilertson, General Counsel for Brown Corporations, requesting that the Grand Forks County Commission consider granting a payment in lieu of taxes option for Brown Corporation.

Bret Burkholder, Correctional Center Administrator, addressed the board.
