GRAND FORKS COUNTY COMMISSION MEETING March 17, 2009 – 4:00 P.M

The Board met pursuant to adjournment with Commissioners Murphy, Knauf, Malm, Schmisek and Pic present.

Moved by Malm, seconded by Knauf, to approve the minutes of the March 4, 2009 meeting. Motion carried.

Moved by Pic, seconded by Schmisek, to approve the order of the agenda adding Bret Burkholder after item number 8. Motion carried.

Moved by Malm, seconded by Knauf, to approve the consent agenda. Items in the consent agenda included: employee status changes for Jenny M. Letexier, Tanya L. Geir, Peggy A. Klockmann, Suzanne Kilichowski and Deb Goodman; bills as submitted by the County Auditor, Check# 138208-138238 and Check# 138355-138593 in the amount of \$703,042.03; overtime; financial report and approval of the Forest Stewardship Applications. Motion carried.

Jim Campbell, Emergency Management Director, addressed the board.

Moved by Pic, seconded by Knauf, to retroactively approve the Chair's signature on the following Grand Forks County Emergency Declaration. Motion carried.

GRAND FORKS COUNTY EMERGENCY DECLARATION

WHEREAS, Grand Forks County has the potential for damages to roads, bridges, culverts, farmlands, homes, businesses and other public facilities from overland flooding and the flooding of tributaries to the Red River of the North as it reaches or exceeds flood stage;

WHEREAS, the impact of these potential damages may threaten the health, well being and public safety of citizens in Grand Forks County; and

WHEREAS, the cost of cleanup, repair and replacement of such damaged facilities may be in excess of available County resources.

Now, THEREFORE, BE IT RESOLVED that Grand Forks County, a municipal corporation by and through the Board of County Commissioners, Grand Forks County, North Dakota, declares Grand Forks County, its cities, its public and private areas, to be an emergency area and orders the activation and utilization of the Emergency Operations Plan, its procedures, attachments and appendices to monitor the situation, develop a detailed damage assessment, alleviate hardship and initiate appropriate relief actions and mitigation measures by departments and agencies of local government to limit the hardships and impact of the emergency upon the citizens of Grand Forks County.

DATED at Grand Forks, North Dakota, this 12th day of March 2009.

Mr. Campbell reported on what is being done for the protection of the Grand Forks County residents. Currently they have empty sandbags at the Grand Forks City Public Works Building, they also have bags and a truck load of sand at the Thompson Fire Department, they have 10,000 bags and sand at Ag Systems in Manvel, there are 10,000 bags at Sweeney Farms in Turtle River

Township and 10,000 bags at Gowan Construction. Mr. Campbell said they feel like they are in good shape with the sandbags and the sand right now.

Moved by Malm, seconded by Pic, to provide one load of sand and sandbags to Grand Forks County residents at no charge and allow the Emergency Management Director to exceed that amount with written documentation from the Grand Forks County Highway Department or the Grand Forks City Fire Chief regarding the perceived threat of flooding. If written documentation is not received a fee will be charged for each additional load of sand. Motion carried.

Moved by Malm, seconded by Schmisek, to allow the Chairman to approve additional funds for the Emergency Response line item in the Emergency Management budget if needed. Motion carried.

Amber Vaughn, Tax Equalization Director, addressed the board.

Moved by Schmisek, seconded by Pic, to approve the abatement application for Real Presence Radio on parcel number 08-2401-00004-000 and reduce the 2007 True and Full Value from \$45,000 to \$0. Motion carried.

Moved by Schmisek, seconded by Knauf, to approve the 2007 abatement applications that qualify for an exemption under NDCC § 57-02-08(20b) and reduce the True and Full Values as follows. Motion carried.

Payment for the sidearm to be through payroll deductions over a period of 13 months. Should an employee leave employment with Grand Forks County, any remaining balance owed will be deducted from their final paycheck. Motion carried.

Debbie Nelson will forward the letter from the North Dakota Department of Transportation regarding the Director's Task Force Transportation Enhancement Projects American Recovery and Reinvestment Act of 2009 to the County Engineer and the Grand Forks County Water Board.

The Building Committee will work with the States Attorney to draft a policy on alcohol usage on County property.
