GRAND FORKS COUNTY COMMISSION MEETING September 1, 2009 – 4:00 P.M.

The Board met pursuant to adjournment with Commissioners Murphy, Knauf, Schmisek, Pic and Malm present.

Moved by Malm, seconded by Schmisek, to approve the minutes of the August 18, 2009 meeting. Motion carried.

Moved by Pic, seconded by Knauf, to approve the order of agenda. Motion carried.

Moved by Schmisek, seconded by Malm, to approve the consent agenda. Items in the consent agenda included: bills as submitted by the County Auditor, Check #141640 – 141653 and Check #141791 - 141957 in the amount of \$625,848.94 and overtime. Motion carried.
