The Board met pursuant to adjournment with Commissioners Knauf, Malm, Schmisek, Murphy and Pic present.

Moved by Malm, seconded by Pic, to approve the minutes of the October 5, 2010 meeting. Motion carried.

Moved by Schmisek, seconded by Murphy, to approve the order of agenda. Motion carried.

Moved by Pic, seconded by Murphy, to approve the consent agenda. Items in the consent agenda included: bills as submitted by the County Auditor, Check #150320 – 150555 in the amount of \$451,155.78 and overtime. Motion carried.

Barb Zavala, Veterans Service Officer, addressed the board.
