## GRAND FORKS COUNTY COMMISSION MEETING

December 21, 2010 – 4:00 P.M.

The Board met pursuant to adjournment with Commissioners Malm, Schmisek, Murphy, Pic and Knauf present.

Moved by Schmisek, seconded by Pic, to approve the minutes of the December 7, 2010 meeting. Motion carried

Moved by Schmisek, seconded by Murphy, to approve the order of agenda removing item number 9, Kirk Motl, Aflac. Motion carried.

Moved by Pic, seconded by Schmisek, to approve the consent agenda. Items in the consent agenda included: employee status changes for Kelly Hutton, Alan S. Frazier, Gary G. Grove, Bernard J. Maxson II, Kelly McLean, Joel Lloyd, Nicole Meisch, Aaron Brorby Davidson, Robert W. Rost, Daniel J. Hill, Hunter Althoff, Adam Landstrom, Erin Hamilton, Cameron McClennahan, James Roberts and Jack Zuger; bills as submitted by the County Auditor, Check #151501-151837 in the amount of \$696,718.68; Liquor/Beer Licenses for Grand Forks Country Club, Rivers Edge Golf Course and the Hitching Post Bar and Grill; and County Deed on parcel 44-2312-00032-019. Motion carried.

Moved by Murphy, seconded by Pic, to approve the Base Realignment Impact Committee Coordinator Agreement. Motion carried.

Moved by Schmisek, seconded by Knauf, to approve the Chair's signature on an amendment to the Office of Economic Adjustment Grant moving \$60,000 to 2011. Motion carried.

Eric Borlaug, North Dakota Public Employees Association, addressed the board.

Moved by Pic, seconded by Knauf, to authorize voluntary payroll deduction for the North Dakota Public Employees Association. Motion carried.

Moved by Schmisek, seconded by Pic, to appoint Leigh Jeanotte, Sue Eisenzimmer, Robert Rost, Cynthia Pic and Michael Coachman to two year terms on the NE Human Service Advisory Board and to appoint David Middleton and Richard Axvig to three year terms to the Grand Forks County Water Board. All terms begin January 1, 2011. Motion carried.

Moved by Murphy, seconded by Schmisek, to open the bid for reprogramming all government P-25 compatible mobile and portable radios in Grand Forks County. Motion carried.

The Grand Forks County Building Code shall meet the provisions of the rules and regulations of the North Dakota State Building Code as amended, a copy of which is on file with the County Building Official and hereby made a part of this by reference with the exception of any local amendments. Motion carried.

Moved by Murphy, seconded by Knauf, to approve deleting 9-4-1(6) from the Grand Forks County Zoning Resolution. Motion carried.

Moved by Pic, seconded by Schmisek, to approve changing 71 of the Grand Forks County Zoning Resolution as presented. Motion carried.

Moved by Murphy, seconded by Knauf, to approve the application of Chad Gibbs for a variance to allow a windbreak to be planned 70' from centerline of a township road in the SE ¼ of section 10, Brenna Township. Motion carried.

Debra Pflughoeft-Hassett, Energy Sustainability Coordinator, addressed the board.

Moved by Pic, seconded by Murphy, to approve the Chairman's signature on the financial award for a North Dakota State Energy Program funding for energy efficient lighting upgrades to the Grand Forks County parking ramp. Motion carried.

Also sign the north side of the Courthouse parking lot as two hour parking. And to increase the Grand Forks County parking ramp fee to \$30.00 effective February 1, 2011. Motion carried.

Moved by Murphy, seconded by Schmisek, to approve the Chairman's signature on the Court Facilities Improvement Grant letter of application. Motion carried.

Lane Magnuson, County Planner, was appointed to be the Grand Forks County representative to the Community Leader Meetings regarding the downstream impacts of the Fargo-Moorhead diversion.
