## GRAND FORKS COUNTY COMMISSION MEETING June 5, 2012 – 4:00 P.M.

The Board met pursuant to adjournment with Commissioners Schmisek, Pic, Murphy and Malm present. Commissioner Knauf was absent.

Moved by Malm, seconded by Pic, to approve the minutes of the May 15, 2012 meeting. Motion carried.

Moved by Pic, seconded by Malm, to approve the order of the agenda. Motion carried.

Moved by Murphy, seconded by Pic, to approve the consent agenda. Items in the consent agenda included: bills as submitted by the County Auditor, Check #160337-160595 in the amount of \$1,048,822.23; employee status changes for Andrew Eyre, Eric Grant, Derek Rakoczy, Justin Benson, and Brian Basting; and overtime. Motion carried.

Lee Finstad, Veterans Service Officer, addressed the board.

Moved by Pic, seconded by Murphy, to approve out-of-state travel for Lee Finstad to attend the National Association of County Veteran Service Officers Conference in Bloomington, Illinois from September 9 – 14, 2012 and amend the Veterans Service Office budget for this travel. Motion carried.
