Moved by Malm, seconded by Pic, to approve the minutes of the July 3, 2012 meetings. Motion carried.

Moved by Malm, seconded by Pic, to approve the order of the agenda, adding a Special Event Permit after the consent agenda. Motion carried.

Moved by Malm, seconded by Knauf, to approve the consent agenda. Moved by Malm, seconded by Pic, to add "extraordinary or" before "severe illness" and also specifying that conditions related to normal pregnancy do not apply to Policies 104-02, Donation of Vacation Leave and 104-06, Donation of Sick Leave. Motion carried.

The Administrative Services Committee will be looking at the human resource and risk management functions of the County at the next meeting.

Moved by Murphy, seconded by Knauf, to change the last sentence of the first paragraph on page 3 of the Grand Forks County Policy 105-26, Grievance Procedures to read as following: The Department Manager must also provide a copy of the written grievance to the person who made the decision being grieved. Motion carried.

Moved by Pic, seconded by Knauf, to approve the Chair's signature on a letter to Secretary Yonkers requesting a meeting in regards to an Enhanced Use Lease at the Grand Forks Air Force Base. Motion carried.
