Moved by Murphy, seconded by Knauf, to cast unanimous vote to appoint Commissioner Pic to serve as Chairman from December 2012 to November 2013. Motion carried unanimously.

Moved by Schmisek, seconded by Knauf, to cast unanimous vote to appoint Commissioner Murphy to serve as Vice Chairman from December 2012 to November 2013. Motion carried unanimously.
