The Board met pursuant to adjournment with Commissioners Pic, Murphy, Knauf, Malm and Schmisek present.

Moved by Malm, seconded by Schmisek, to approve the minutes of the January 18, 2013 and January 22, 2013 meetings. Motion carried.

Moved by Murphy, seconded by Knauf, to approve the order of the agenda. Motion carried unanimously.

Moved by Knauf, seconded by Schmisek, to approve the consent agenda. Items in the consent agenda included: bills as submitted by the County Auditor, Check #164556-164706 in the amount of \$722,127.67; employee status changes for Mary Reyerson, Sarah Monk, Deb Fontaine, Ann Black and Matthew Helm; overtime; and a Game of Chance Permit for Dunham Family Adoption. Motion carried unanimously.

Patrick Dame, Grand Forks Regional Airport Executive Director, presented a video and cake in celebration of the 2012 record year for passenger boarding at the Grand Forks International Airport.

Richard Onstad, Highway Superintendent, addressed the board regarding the Highway Department bids.

Moved by Murphy, seconded by Malm, to return the unopened bid received from Cretex Concrete Products West because the bid requirement to include the bidder's bond in a separate envelope was not followed. Motion carried unanimously.

Mr. Onstad was directed to rebid the precast bridge beams at a later date, if needed.

Moved by Knauf, seconded by Murphy, to contribute to the ND National Guard Reception in Washington, DC in March 2013, contingent upon contributions from Grand Forks City and the Grand Forks Chamber Commerce. Motion carried unanimously.
