GRAND FORKS COUNTY COMMISSION MEETING January 6, 2015 – 4:00 P.M.

The Board met pursuant to adjournment with Commissioners Knauf, Malm, Schmisek, Pic and Falck present.

Presiding Judge Jensen administered the Oath of Office to Grand Forks County Sheriff Bob Rost and Grand Forks County States Attorney Peter Welte.

Moved by Malm, seconded by Pic, to approve the minutes of the December 16, 2014 meeting. Motion carried unanimously.

Moved by Schmisek, seconded by Malm, to approve the minutes of the December 18, 2014 Grand Forks County Appeal Hearing. Motion carried unanimously.

Moved by Pic, seconded by Schmisek, to approve the order of agenda. Motion carried unanimously.

Moved by Pic, seconded by Falck, to appoint the States Attorney as parliamentarian for the board meetings. Motion carried unanimously.

Moved by Schmisek, seconded by Pic, to adopt Robert's Rules of Order as the official procedure by which the Board of County Commissioners will conduct meetings. Motion carried with Knauf, Schmisek and Pic voting aye and Malm and Falck voting nay.

Commissioner Malm requested that all overtime would be submitted with an explanation.

Moved by Schmisek, seconded by Malm, to approve the consent agenda. Motion carried unanimously.

Moved by Pic, seconded by Falck, to approve the Chair's signature on the agreement between Grand Forks County and Industrial Contract Services, Inc. for the Grand Forks County Office Building exterior stair project. Motion carried unanimously.
