GRAND FORKS COUNTY COMMISSION MEETING June 16, 2015 – 4:00 P.M.

The Board met pursuant to adjournment with Commissioners Knauf, Malm, Engen, Pic and Falck present.

Honorable Judge Lolita Hartl Romanick administered the Oath of Office to David Engen.

Moved by Malm, seconded by Pic, to approve the minutes of the June 2, 2015 meeting. Motion carried unanimously.

Moved by Malm, seconded by Falck, to approve the minutes of the June 2, 2015 County Board of Equalization meeting. Motion carried unanimously.

Moved by Pic, seconded by Malm, to approve the order of the agenda. Motion carried unanimously.

Moved by Malm, seconded by Pic, to approve the consent agenda. Items in the consent agenda included: bills as submitted by the County Auditor, Check #9104-9364 in the amount of \$959,865.98 and purchasing card transaction in the amount of \$18,633.32; employee status changes for Sarah Monk, Alicia Schumacher, Kristi Schmitke and Anna Dorward-Engstrom; overtime; May financial report; and bond for check reissue.
