Moved by Engen, seconded by Falck, to cast unanimous vote to appoint Commissioner Malm to serve as Chairman from December 2015 to November 2016. Motion carried unanimously.

Moved by Falck, seconded by Engen, to cast unanimous vote to appoint Commissioner Pic to serve as Vice Chair from December 2015 to November 2016. Motion carried unanimously.

Moved by Pic, seconded by Engen, to approve the minutes of the November 17, 2015 meeting. Motion carried unanimously.

Moved by Falck, seconded by Engen, to approve the order of the agenda. Motion carried unanimously.

Moved by Engen, seconded by Pic, to approve the consent agenda.
