## GRAND FORKS COUNTY COMMISSION MEETING February 2, 2016 – 4:00 P.M.

The Board met pursuant to adjournment with Commissioners Malm, Pic, Falck, Engen and Knauf present.

Moved by Knauf, seconded by Pic, to approve the minutes of the January 19, 2016 meeting. Motion carried unanimously.

Moved by Falck, seconded by Engen, to approve the order of the agenda, adding Ryan Riesinger, Grand Forks Regional Airport Authority Executive Director as number 5 on the agenda and remove the Emergency Management Director. Motion carried unanimously.

Moved by Pic, seconded by Knauf, to approve the consent agenda. Items in the consent agenda included: bills as submitted by the County Auditor, Check #12713-12869 in the amount of \$644,715.34; employee status changes for Roberta Bursheim, Jonathon Kriegh, David James Wyman, Gregory A. Sampson, Jackie J. Johnson and Tyler Jeffrey Bakken; overtime; and game of chance permit for Midway Public School. Motion carried unanimously.

Ryan Riesinger, Grand Forks Regional Airport Authority Executive Director, introduced himself to the board.

Debbie Swanson, Grand Forks Public Health Director, gave an update on the Social Detox Facility. Grand Forks City approved hiring a Grand Forks City employee to operate the facility, which will be included in the Grand Forks Public Health Department budget. The budget is partially funded by Grand Forks County.
