The Board met pursuant to adjournment with Commissioners Malm, Pic, Falck, Engen and Knauf present.

The Chair called for any additions or corrections to the April 19, 2016 minutes, hearing none, the minutes were approved as presented.

Moved by Pic, seconded by Engen, to approve the order of the agenda. Motion carried unanimously.

Moved by Falck, seconded by Pic, to approve the consent agenda.
