The Board met pursuant to adjournment with Commissioners Malm, Falck and Engen present. Commissioners Pic and Knauf were absent.

The Chair called for any additions or corrections to the July 19, 2016 minutes, hearing none the minutes were approved as presented.

Moved by Falck, seconded by Engen, to approve the order of agenda, adding Mike McEnroe and Bridgie Hansen, Juvenile Detention Administrator, after the consent agenda. Motion carried unanimously.

Moved by Engen, seconded by Falck, to approve the consent agenda. Items in the consent agenda included: bills as submitted by the County Auditor, Check #15508-15654 in the amount of \$1,628,362.32; employee status change for Virginia Rodriguez, Jacob Randall and Benjamin Welin; overtime; bonds for check reissue and an Agreement for Performance of Assessing Duties with Logan Center Township. Motion carried unanimously.

Mike McEnroe requested approval to sell eight quarters of land in Lakeville Township to the US Department of Agriculture, Fish and Wildlife Service. David Jones, States Attorney, will research the issue and bring back the information to the next meeting.

Debbie Nelson, Finance and Tax Director, will contact Larimore City and inform them that they are allowed to waive the specials and taxes on the property and purchase it from Grand Forks County, according to NDCC 57-28-17.
