The Board met pursuant to adjournment with Commissioners Malm, Pic, Falck, Engen and Knauf present. Commissioner Pic participated by telephone.

The Chair called for any additions or corrections to the September 20, 2016 minutes, hearing none the minutes were approved as presented.

Moved by Falck, seconded by Engen, to approve the order of the agenda, adding Sheriff Rost after item number 9. Motion carried unanimously.

The Chair called for any changes to the consent agenda, hearing none the consent agenda was approved. Items in the consent agenda included: bills as submitted by the County Auditor, Check #16365-16555 in the amount of \$3,710,907.45; employee status change for Jakee Stoltz; overtime; bond for check reissue; August Financial Report; and County Deed on parcel number 15-5301-00006-000.

Scot Hoeper, Social Services Director, addressed the board.

Moved by Pic, seconded by Knauf, to out-of-state travel for Alicia Schumacher to attend a conference in Charleston, South Carolina on October 18 -21, 2016 and approve out-of-state travel for Rachel Behm, Traci VanBeek and Alana Johnston to attend a conference in Orlando, Florida on October 12-14, 2016. All expenses will be paid by CVIC. Motion carried unanimously.

Moved by Engen, seconded by Knauf, to approve a temporary position for the Child Protection Department, contingent upon approval by the ND Department of Human Services. Motion carried unanimously.

Mr. Hoeper invited the board to attend a Regional Social Services Director meeting in Ramsey County on November 2, 2016.

Moved by Falck, seconded by Knauf, to adjust the pay scale to 3% separation between steps, beginning at step seven and moving outward, effective 10/1/2016.
