The Board met pursuant to adjournment with Commissioners Falck, Engen, Knauf and Malm present. Commissioner Pic was absent. Vice Chair Falck was the Acting Chair of the meeting.

Moved by Malm, seconded by Engen, to approve the minutes of the August 15, 2017 meeting. Motion carried unanimously.
