The Board met pursuant to adjournment with Commissioners Pic, Falck, Engen, Knauf and Malm present.

Moved by Malm, seconded by Falck, to approve the minutes of the October 17, 2017 and October 23, 2017 meetings. Motion carried unanimously.

Moved by Engen, seconded by Malm, to approve the order of agenda adding Social Services after item # 5. Motion carried unanimously.

Moved by Malm, seconded by Knauf, to approve the consent agenda.
