The Board met pursuant to adjournment with Commissioners Falck, Engen, Knauf and Malm present. Chair Pic was absent. Vice Chair Falck was the Acting Chair of the meeting.

Moved by Malm, seconded by Engen, to approve the minutes of the April 4, 2017 meeting. Motion carried unanimously.

Moved by Malm, seconded by Knauf, to approve the order of agenda. Motion carried unanimously.

Moved by Knauf, seconded by Malm, to approve the consent agenda. Items in the consent agenda included: bills as submitted by the County Auditor, Check #19556-19771 in the amount of \$1,403,875.42 and purchasing card transactions in the amount of \$31,603.50; employee status changes for Mark Rice, George Jirout, Clarissa Van Eps, Sarah Everett, Noah Prudhomme, Kenneth Nelson, Alice Thiegles, Ryan Hutton, Sara Bondy and Katherine M.
