Kari Goelz, Emergency Manager, addressed the board.

Moved by Pic, seconded by Falck, to approve the following Grand Forks County Emergency Declaration. Motion carried unanimously.

## GRAND FORKS COUNTY EMERGENCY DECLARATION

WHEREAS, Grand Forks County experienced extreme weather conditions including excessive rainfall of 8 -10" and high winds in parts of Grand Forks County during the overnight of June 30<sup>th</sup> into the morning of July 1<sup>st</sup>, 2020 resulting in significant overland flooding and above average runoff;

WHEREAS, Grand Forks County has the potential for further damage to roads, bridges, culverts, farmlands, homes, businesses and other public infrastructure facilities from overland flooding and the flooding of streams, coulees and tributaries;

WHEREAS, the impact of these potential damages may threaten the health, well-being and public safety of citizens in Grand Forks County; and

WHEREAS, the cost of response, cleanup, repair and replacement of such damaged facilities may exceed available County resources.

Now, THEREFORE, BE IT RESOLVED that Grand Forks County, a political subdivision of the State of North Dakota, by and through the Board of County Commissioners, Grand Forks County, North Dakota, declares Grand Forks County, its cities, its public and private areas, to be an emergency area and orders the activation and utilization of the Emergency Operations Plan, its procedures, attachments and appendices to monitor the situation, develop a detailed damage assessment, alleviate hardship and initiate appropriate relief actions and mitigation measures by

departments and agencies of local government to limit the hardships and impact of the emergency upon the citizens of Grand Forks County.

DATED at Grand Forks, North Dakota, this 7th day of July, 2020.

Nick West, County Engineer, addressed the board regarding the flood damage. He, also, informed the board that a couple of months ago he and Sharon Lipsh, the Walsh County Superintendent, submitted an application to the State for a mitigation project in the Manvel/Oslo, area along the Red River because of the repetitive losses. They have not heard yet if they will fund the project. He would like to see other mitigation projects, but they are very expensive and he does not know how we would pay for them.

Dean Dahl, Information Systems Director, addressed the board regarding Microsoft Office 365. He said the cost would be \$100,000 per year, \$61,000 has been included in the 2021 preliminary budget. A hybrid system would be \$50,000 per year or another option would be to not purchase anything and continue with the current system.

The board did not take any action but left \$61,000 in the budget for Microsoft Office 365.

Sheriff Schneider addressed the board.

Moved by Rost, seconded by Falck, to approve the Chair's signature on a National Recreation Boat Safety Grant. Motion carried unanimously.

Moved by Pic, to approve the State Homeland Security Grant Program – Operation Stonegarden grant application with the Chair's signature. Motion dies for lack of a second.

Moved by Pic, second by Rost, to accept the State Homeland Security Grand Program-Operation Stonegarden grant with special conditions with the Chair's signature. Motion carried unanimously.

Debbie Nelson, Finance and Tax Director, presented the 2021 preliminary budget.

Moved by Falck, seconded by Rost, to approve the 2020 preliminary budget with a net levy of \$26,678,960 and set the budget hearing for September 15, 2020 at 4:00pm. Motion carried unanimously.

Bill Gerszewski, Buildings and Grounds Manager, addressed the board.

Moved by Rost, seconded by Engen, to accept the proposal from Johnson Controls for \$11,769 for repairs to the Courthouse direct exchange cooling units. Motion carried unanimously.

Tom Ford, Director of Administration, addressed the board.

Moved by Falck, seconded by Pic, to approve an additional change order in the amount of \$26,090 from ICS for the Grand Forks County Parking Ramp Project. The total change order amount is \$90,330 to date. Motion carried unanimously.

Moved by Pic, seconded by Rost, to approve a \$6,000 amendment to the AE2S Contract for engineering fees on the Grand Forks County Parking Ramp Project. Motion carried unanimously.
