Debbie Nelson, Finance and Tax Director, presented the 2022 budget.

No one appeared for the budget hearing and the hearing was closed.

Moved by Rost, seconded by Falck, to approve the 2022 budget as presented, in the amount of \$26,960,341 which includes a 4% cost of living increase on January 1, 2022, a 2% market increase on

April 1, 2022, to include the Sheriff, State's Attorney and the Commission and a step increase for all qualified employees on their seniority date. Motion carried unanimously. A copy of the final budget is on file in the County Finance and Tax Office.

Moved by Engen, seconded by Knauf, to approve the service agreements with CVIC, Youthworks, Attendant Care Services, Circle of Friends Humane Society, Red River Children's Advocacy Center, Greater Grand Forks Community Service and Restitution Program, the Greater Grand Forks Young Professionals and the Safe Kids. Motion carried unanimously.

Tom Ford, Director of Administration and Michele Thiel, Human Resource Director, addressed the board.

Moved by Falck, seconded by Knauf, to have employees who have tested positive for COVID-19, the employee has had a close contact with someone with COVID-19 or the employee has a household member who tests positive for COVID-19, to work with Human Resources and Public Health to follow Public Health's best practices to return to work, to work remotely if possible and to continue to offer administrative leave as needed. Motion carried unanimously.

Haley Wamstad, State's Attorney, addressed the board.

Moved by Knauf, seconded by Rost, to approve the Macro Agreement, leasing copiers and printers in the State's Attorney's Office, with the Chair's signature. Motion carried unanimously.

Commissioner Falck addressed the board.

Moved by Rost, seconded by Engen, to designate Commissioner Falck, Bret Burkholder, Tom Ford, Kyle Kvamme, Tom Wesley, an engineer and contractor appointed by ICON Architectural Group, as members of the selection committee for the Construction Management At-Risk RFQ, according to NDCC 48-01.2-20. Haley Wamstad will serve as the legal consultant for the committee. Motion carried unanimously.

Moved by Engen, seconded by Rost, to set a proposed budget for the Correctional Center /Juvenile Detention public improvement project not to exceed \$31 million. Motion carried unanimously.

Moved by Rost, seconded by Engen, to allow the Selection Committee to set the commencement and completion date of the Correctional Center/Juvenile Detention public improvement project. Motion carried unanimously.

Motion by Rost, seconded by Falck, to adjourn. Motion carried unanimously. The meeting adjourned at 4:55pm. The next meeting will be held on September 21, 2021 at 4:00pm.
