Moved by Knauf, seconded by Falck, to approve the Grand Sky subleases for InnoVets Grand Sky MT1, LLC and Grand Sky Airfield Operations, LLC and to authorize Mr. Schlossberg to forward the subleases to the Air Force Civil Engineering Center (AFCEC) for approval. Motion carried unanimously.

Haley Wamstad, State's Attorney, addressed the board.

Todd Mitzel, ICON Architectural Group, addressed the board.

Moved by Rost, seconded by Knauf, to move forward with a Construction Manager at Risk RFP on the County Correctional Facility Expansion/Juvenile Detention Center Project based on the following determinations:

1. That is in the best interest of the public to utilize the construction manager at-risk public improvement delivery method.

- 2. That the construction manager at-risk planning and design phase services will not duplicate services normally provided by an architect or engineer.
- 3. That the construction manager at-risk construction services will be in addition to and not duplicate the services provided for in the architect and engineer contracts. Motion carried unanimously.

Moved by Engen, seconded by Rost, to approve the ICS Inc County Office Building and Courthouse Safety Project Change Order of a \$10,000 deduct, with the Chair signature. Motion carried unanimously.

Debbie Swanson, Public Health Director, gave a COVID-19 update.

Moved by Knauf, seconded by Rost, to approve the 2022 Social Detox Facility Funding Agreement with the Chair's signature. Motion carried unanimously.

Kari Goelz, Emergency Management Director, addressed the board.

Moved by Falck, seconded by Knauf, to approve an agreement with Red River Regional Council, with the Chair's signature, to complete a FEMA Hazard Mitigation Grant Application for a home buyout in Arvilla. Grand Forks County will be a pass-through entity and will assume no financial responsibility. Motion carried unanimously.

Moved by Rost, seconded by Engen, to approve the Memorandum of Agreement between Grand Forks County and Mark Pierce with the Chair's signature. Motion carried unanimously.

Bridgie Hansen, Juvenile Detention Administrator, addressed the board regarding the Juvenile Detention Center and Attendant Care.

Tom Ford, Director of Administration, Haley Wamstad, State Attorney and Michele Thiel, Human Resource Director addressed the board regarding American Rescue Plan Act (ARPA) premium pay.

Sheriff Schneider said the ARPA premium pay should also apply to the six-support staff at the Sheriff's Department because they meet the criteria of essential workers.

Moved by Rost, seconded by Engen, to approve premium pay for the six-support staff at the Sheriff's Department because they meet the criteria outlined and allow other departments to make a request for premium pay. Motion failed with Pic, Falck and Knauf voting nay and Rost and Engen voting aye.

Moved by Falck, seconded by Engen, to move forward with the selection of a Home Rule Charter Committee at the next Commission Meeting on December 21, 2021. Motion carried unanimously.

Debbie Nelson, Finance and Tax Director, addressed the board.

Moved by Rost, seconded by Falck, to approve the following precincts for the 2022 elections:

Moved by Rost, seconded by Knauf, to set the County Board of Equalization for Tuesday, June 7, 2022 at 4:00pm. Motion carried unanimously.
