Moved by Engen, seconded by Pic, to approve the Contract for Defense Services with Swanson & Warcup, Ltd for mental health services with the Chair signature, effective January 1, 2022 – June 30, 2022. Motion carried unanimously.

Moved by Knauf, seconded by Rost, to apply for a Court Facilities Improvement Grant for the Front Entrance Security project as designed by JLG. The County would be responsible for the 25% match. Motion carried unanimously. Tom Ford, Director of Administration will be directed to apply for the grant.

The Chair said the whole Commission will be a part of the Administrative Services Committee and the Public Safety and Infrastructure Committee from this point forward.

Moved by Rost, seconded by Pic, to adjourn. The meeting adjourned at 4:48pm. The next meeting will be held on February 1, 2022 at 4:00pm.
