The vacancy on the County Planning and Zoning Board remains open since no applications were received.

The appointment to the Grand Forks County Weed Board will be tabled until the next meeting on March 2, 2021.

Debbie Swanson, Public Health Director, gave a COVID-19 update.

Kari Goelz, Emergency Management Director, addressed the board.

Ms. Goelz informed the board the Department of Emergency Services Command Package will be moved from the GF County Water Rescue building to the Grand Forks Air Force Base and then to a hanger at Grand Sky, upon completion of the hanger.

The Smart Restart Plans will remain in place for all entities using the Grand Forks County Fairgrounds. This will be reconsidered at the March 16, 2021 Commission Meeting. Kari Goelz, Emergency Management Director will be asked for a recommendation at that meeting.

Nick West, County Engineer, addressed the board.

Tom Ford, Director of Administration, said bids will be opened for the County Office Building/Courthouse Safety Project on Thursday, February 18, 2021 at 2:00pm and a Special Commission Meeting will be called early next week to review the bids.

Commissioner Engen informed the board about a request he received from Northwood Deaconess Health Center (NDHC) to sign a Certification of Significant Community Support in support of a major renovation project that will take place at NDHC.

Moved by Falck, seconded by Rost, to approve the Vice Chair's signature on a Certification of Significant Community Support for the Northwood Deaconess Health Center renovation project, to be signed and dated after March 8, 2021. Motion carried with Falck, Rost and Knauf voting aye. Chair Pic and Commissioner Engen recused themselves from voting because of a potential conflict of interest.

Commissioner Rost volunteered to include the County Coroner under his Commission Portfolio.
