There will be an Administrative Services Committee at 2:30pm on September 3, 2024 to discuss the Space Study.

Debbie Nelson, Finance and Tax Director, addressed the board.

Moved by Hagen, seconded by Pic, to establish an Early Voting Precinct at the Alerus Center, October 29 – November 2, 2024, the hours will be 10:00am – 6:00pm Tuesday thru Friday and 10:00am – 2:00pm on Saturday. Motion carried unanimously.

Moved by Rost, seconded by Hagen, to establish an Absentee Ballot Precinct for the November 5, 2024 General Election. Motion carried unanimously.

Moved by Hagen, seconded by Pic, to rescind the Subrecipient Monitoring Policy. Motion carried unanimously.

Moved by Pic, seconded by Hagen, to approve the Johnson Controls Multi-Building Controls Retrofit Proposal for \$1,030,300 contingent upon approval by the State's Attorney. Motion carried unanimously. The cost was reduced to \$965,330.

Tom Ford, County Administrator, addressed the board.

Moved by Rost, seconded by Hagen, to approve the Chair's signatures on two ND Department of Transportation grants for Safe Kids Grand Forks. Motion carried unanimously.

Moved by Rost, seconded by Pic, to approve the Chair's signature on a Letter of Support to the NDDOT regarding the intersection of US Highway 2 and Grand Forks County Road 5. Motion carried unanimously.

Commissioner Rustad acknowledged and thanked Tom Ford for his long hours and hard work on the intersection project.

Moved by Hagen, seconded by Rustad, to adjourn. The meeting adjourned at 5:58pm. The next meeting will be held on September 3, 2024 at 4:00pm.
